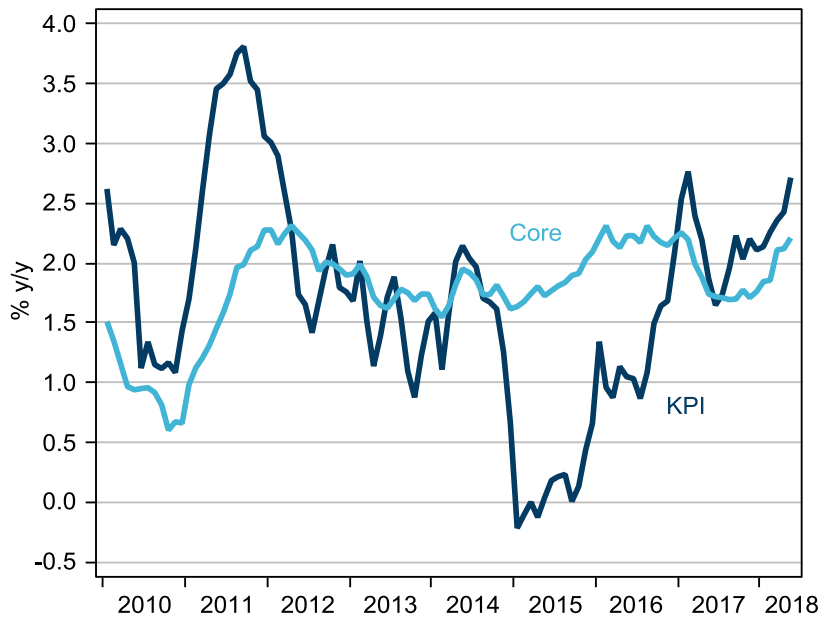

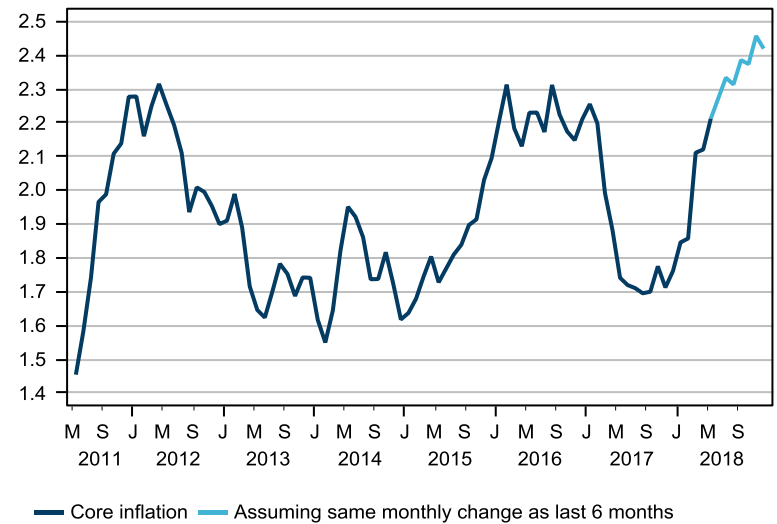

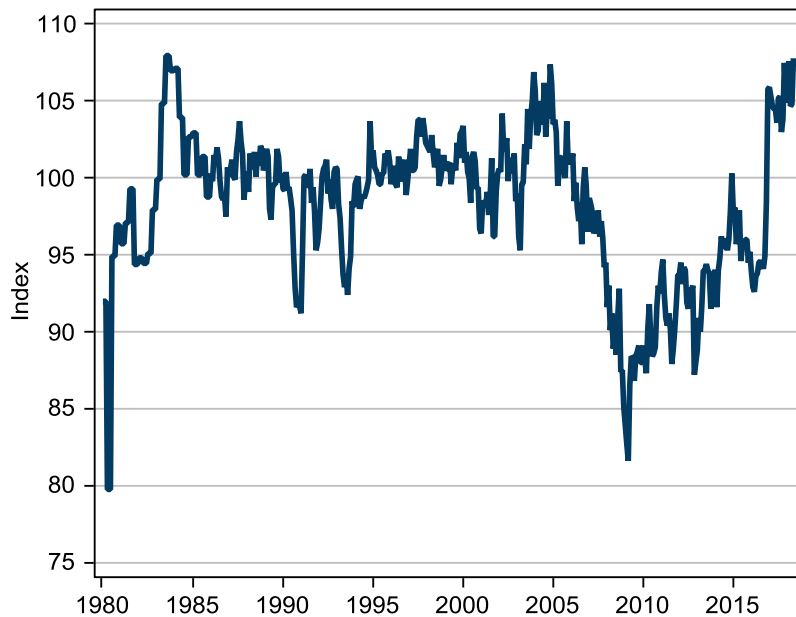
Framräknat med nuvarande månadstakt

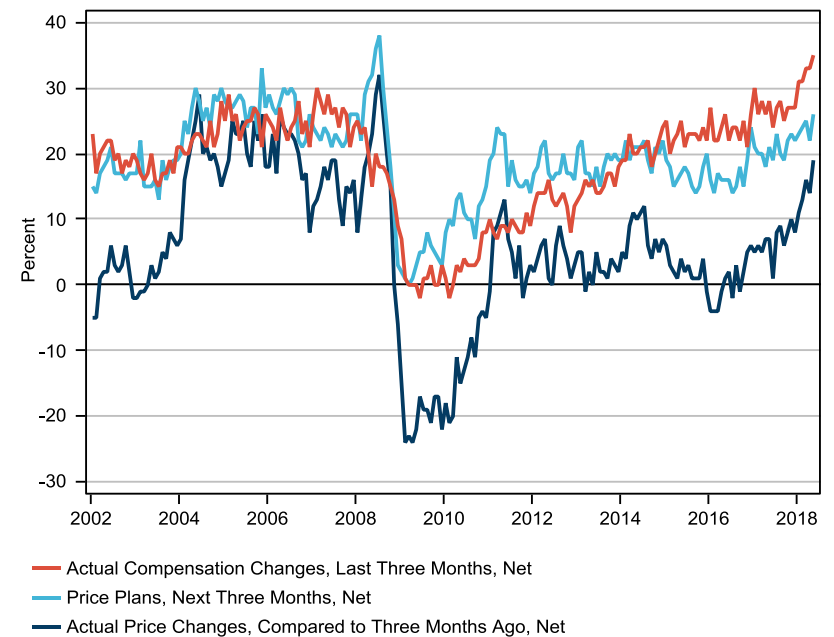

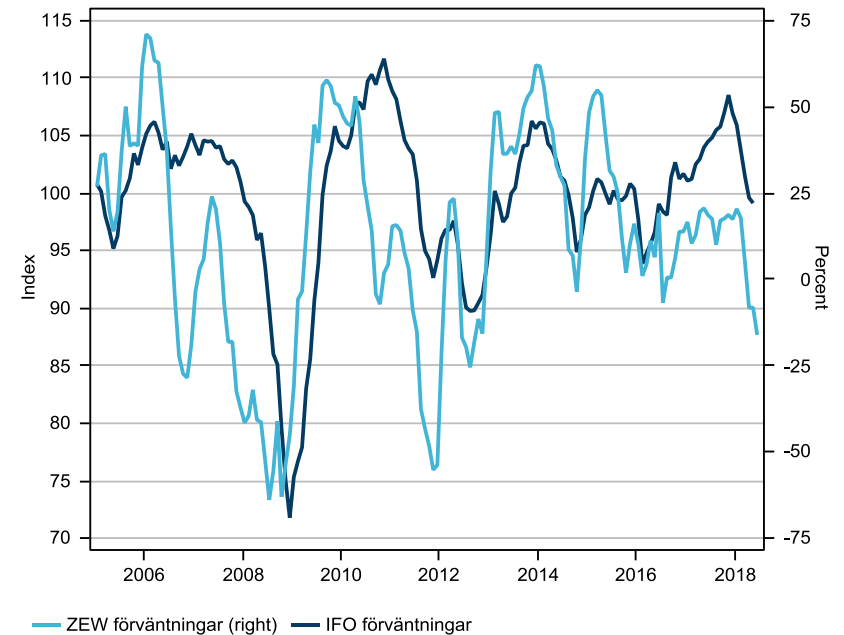
ZEW: Fortsatt lägre förväntningar

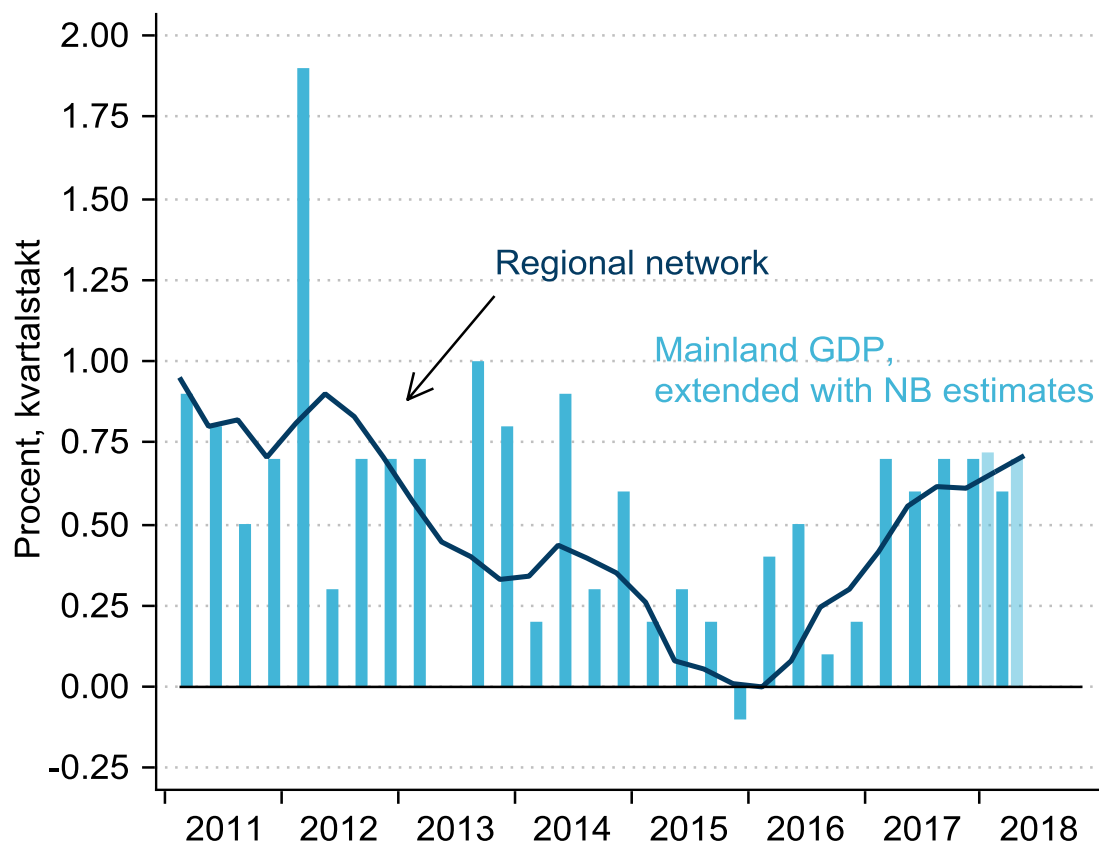

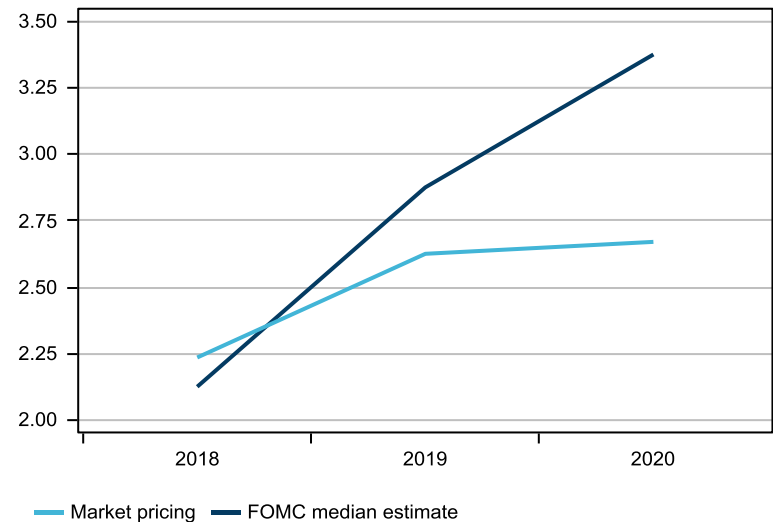

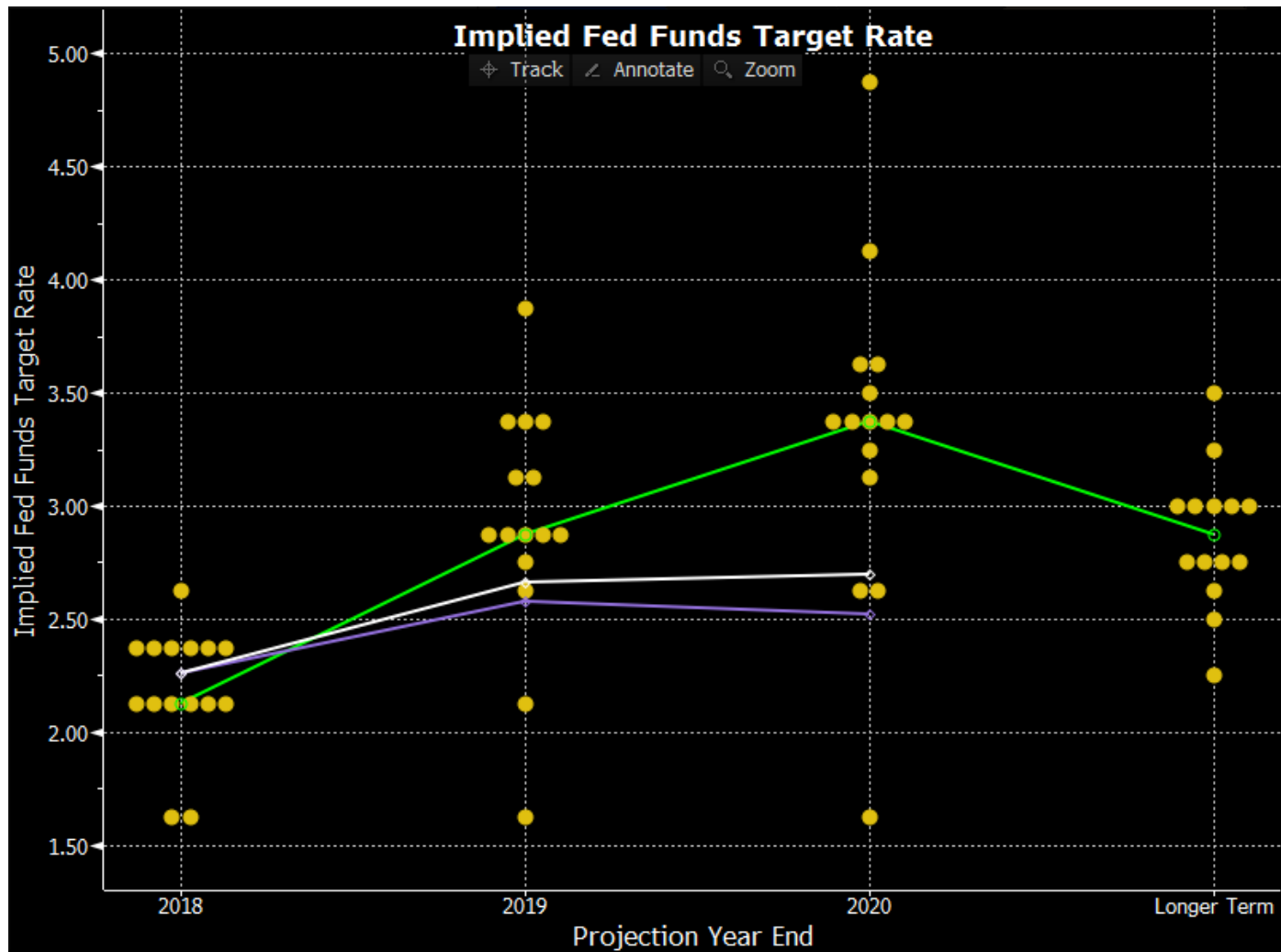

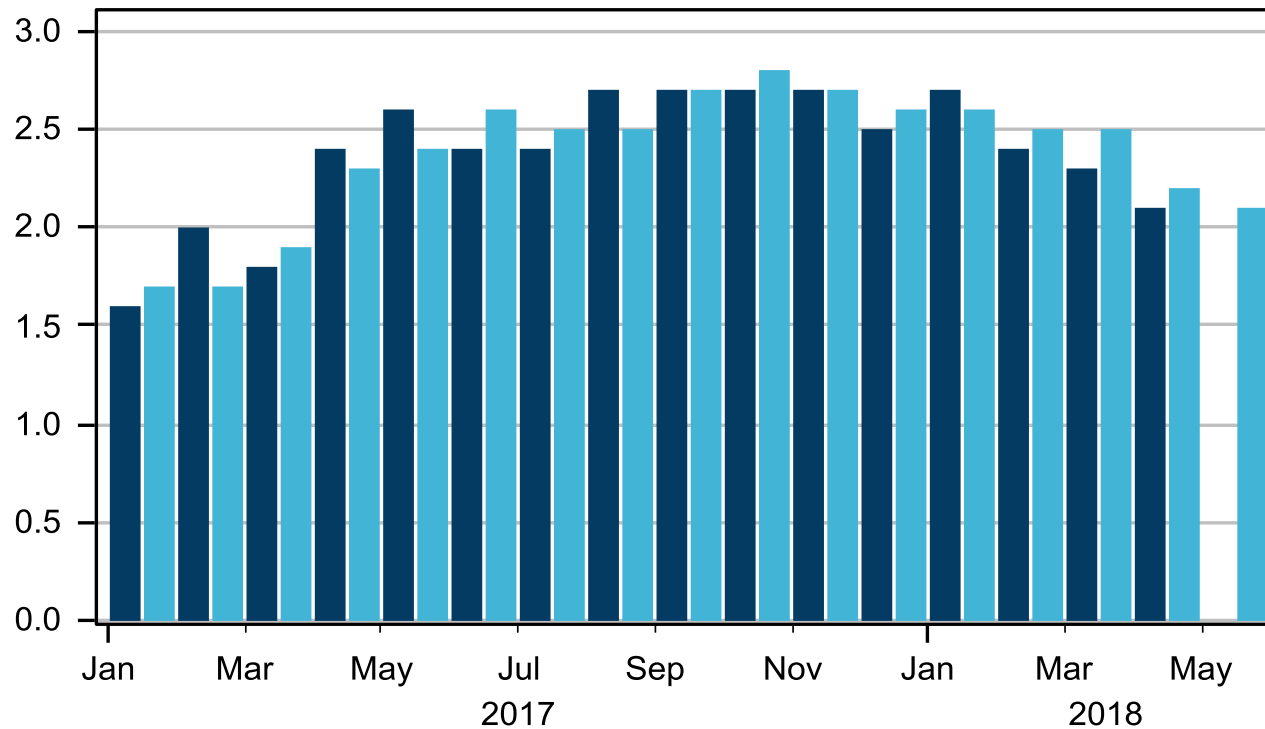

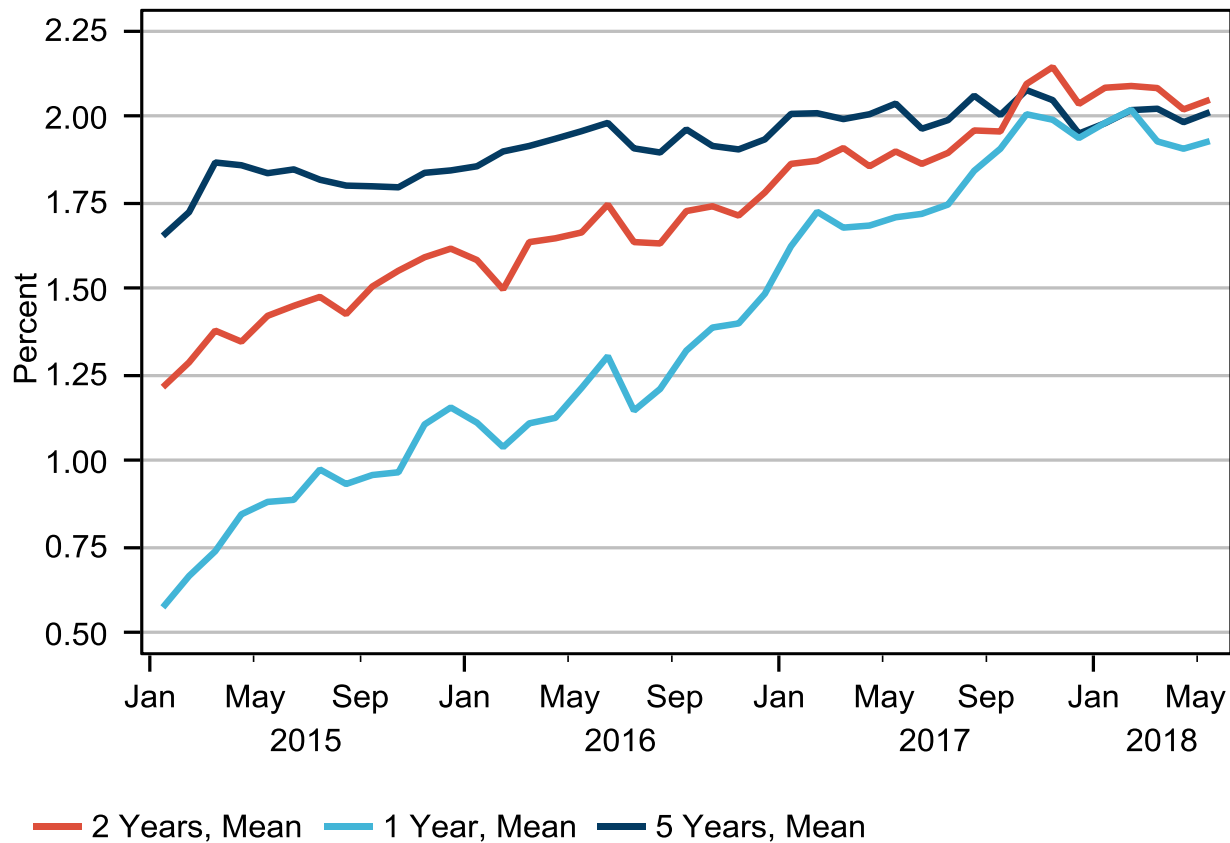
UK: Inflation
