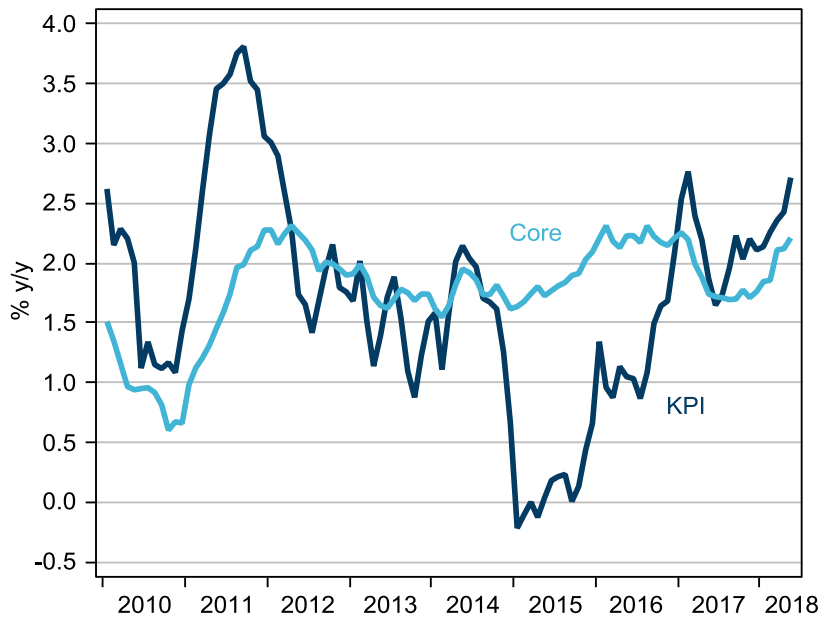

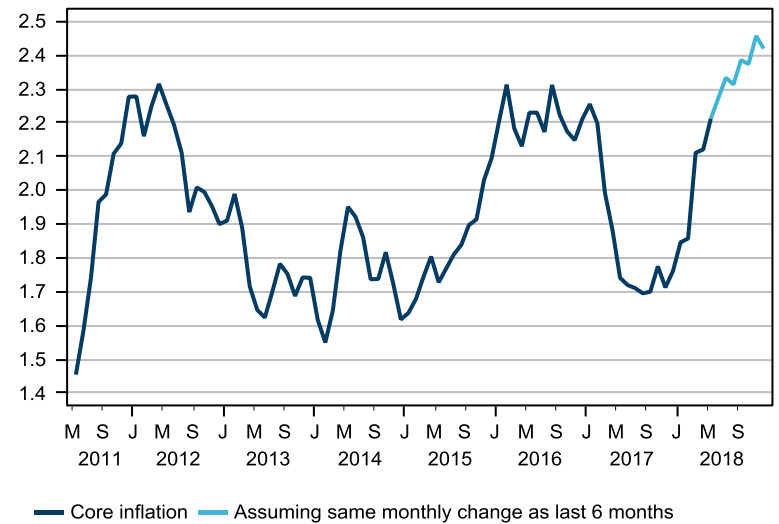

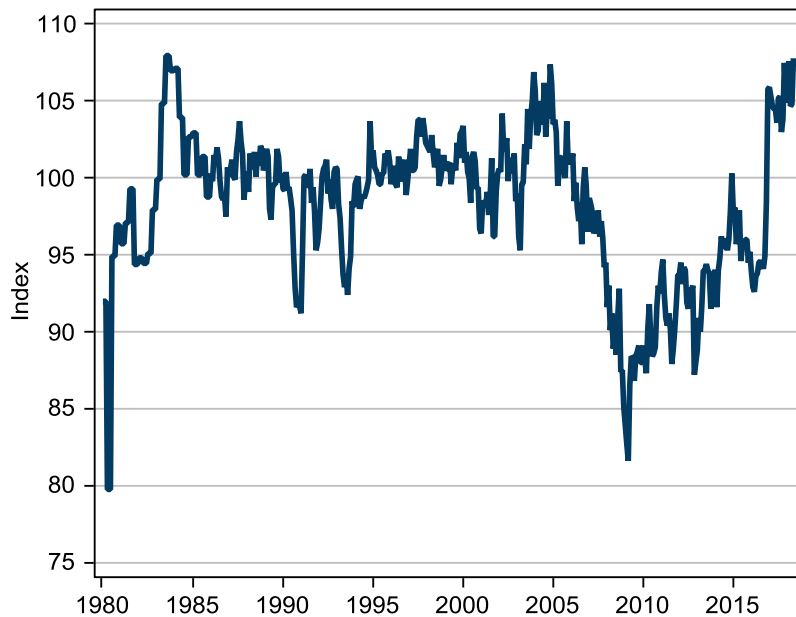
## Framräknat med nuvarande månadstakt

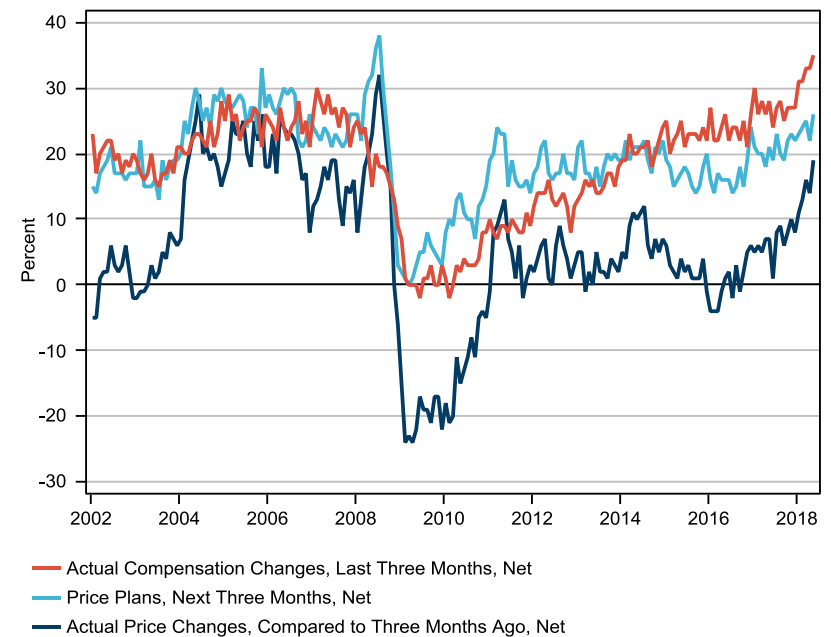

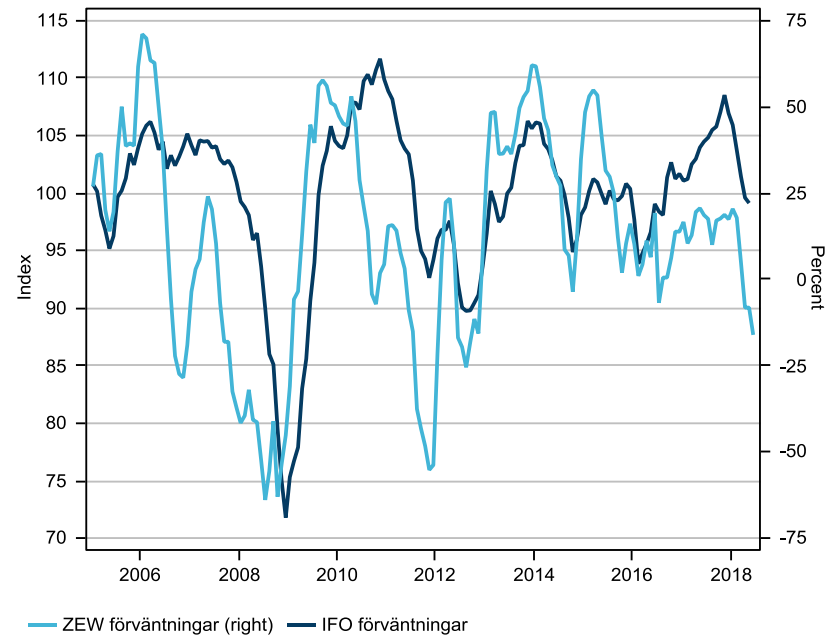
# ZEW: Fortsatt lägre förväntningar

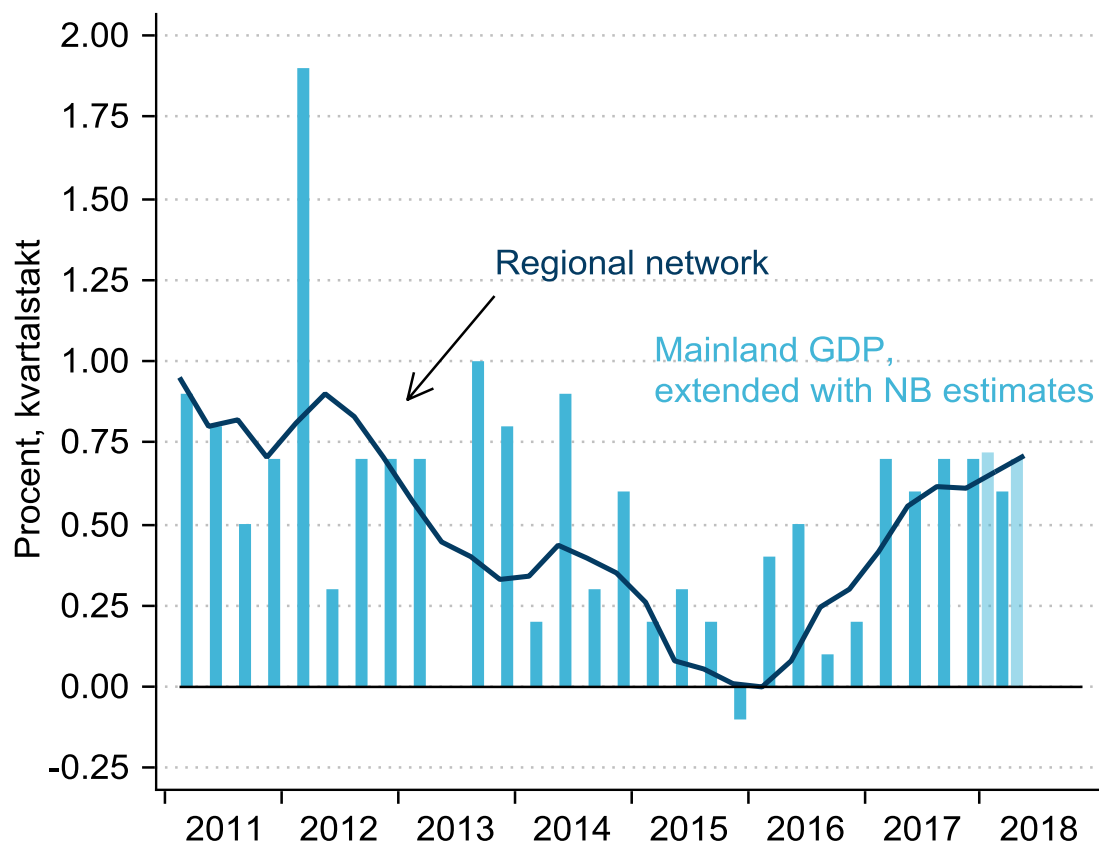

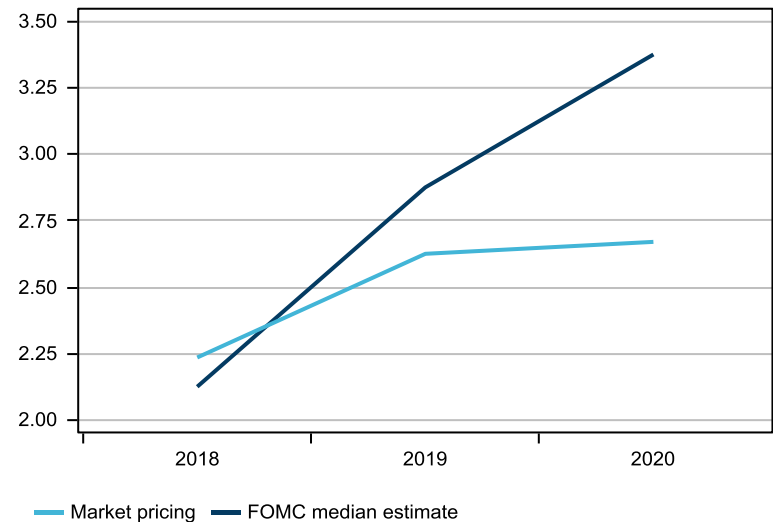

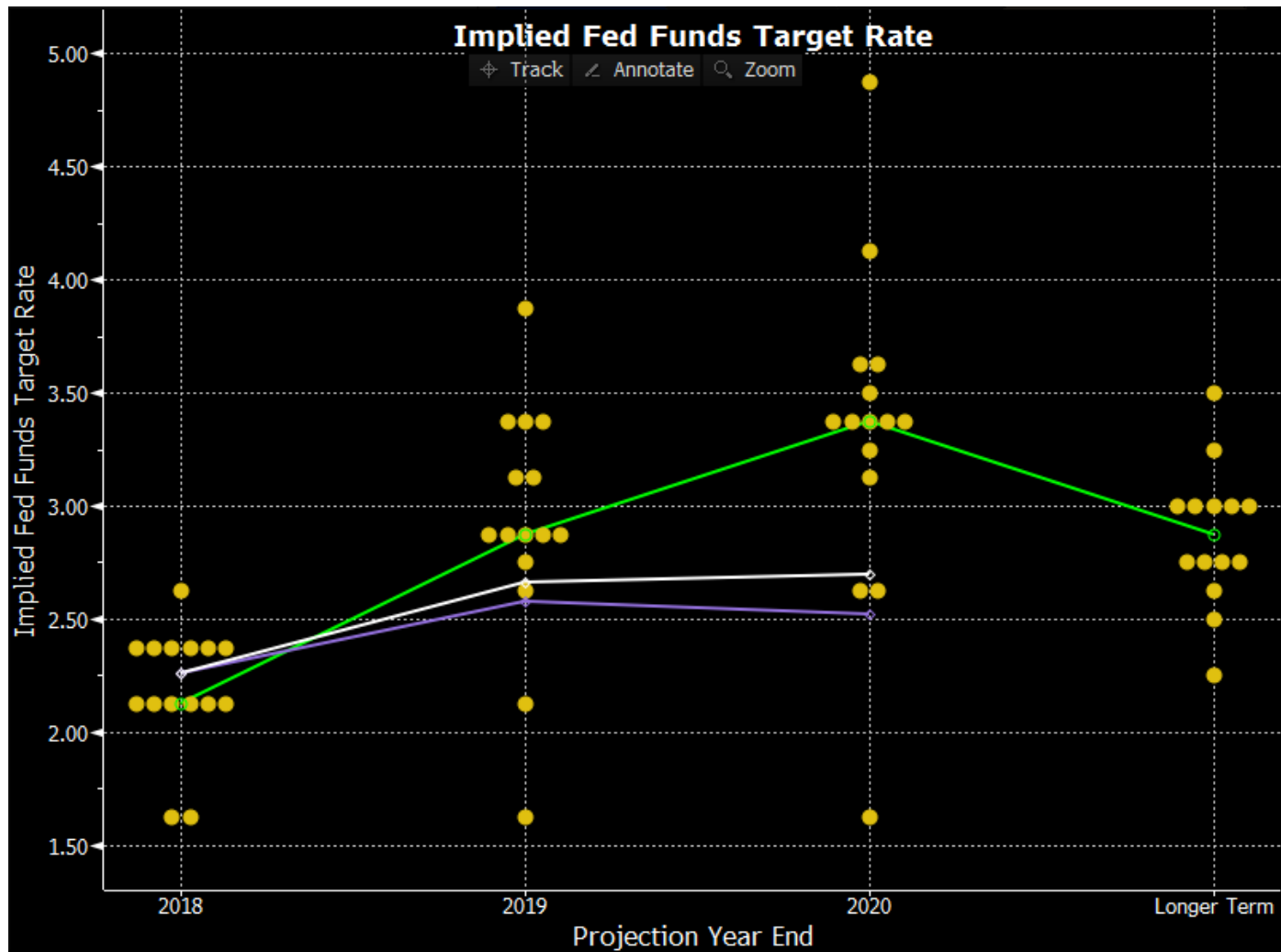

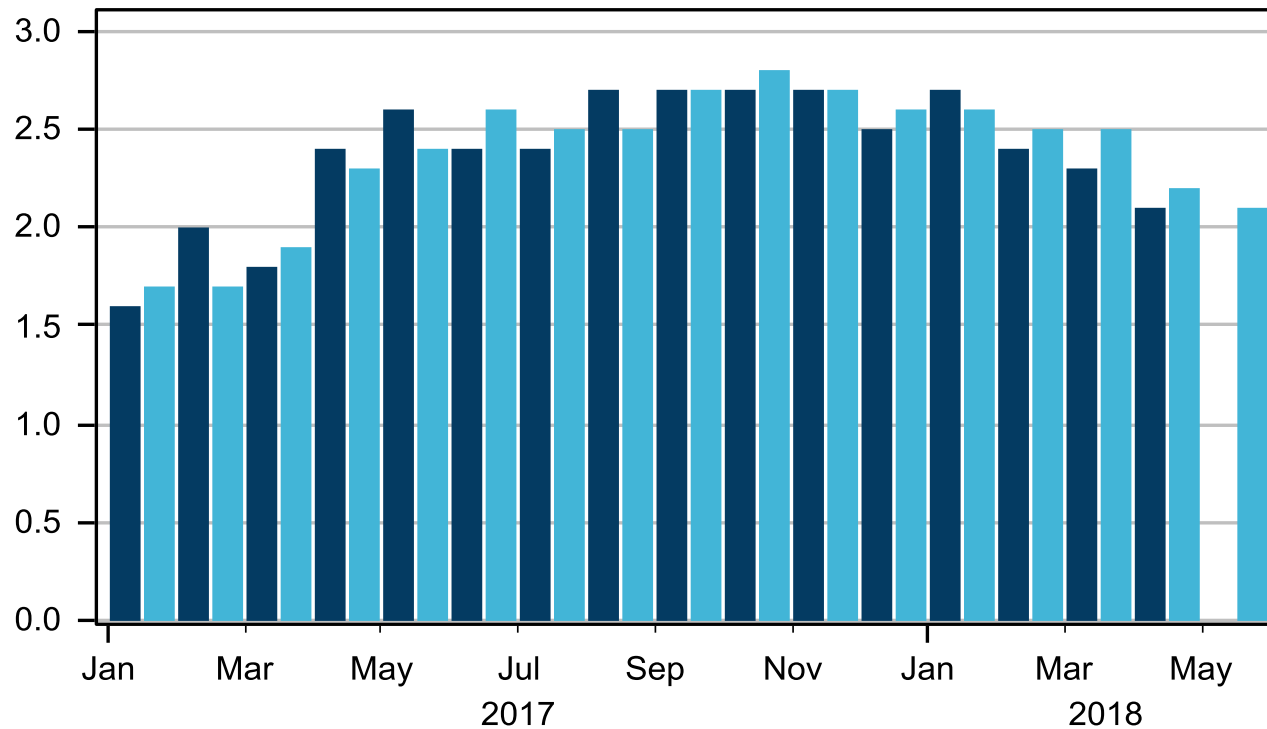

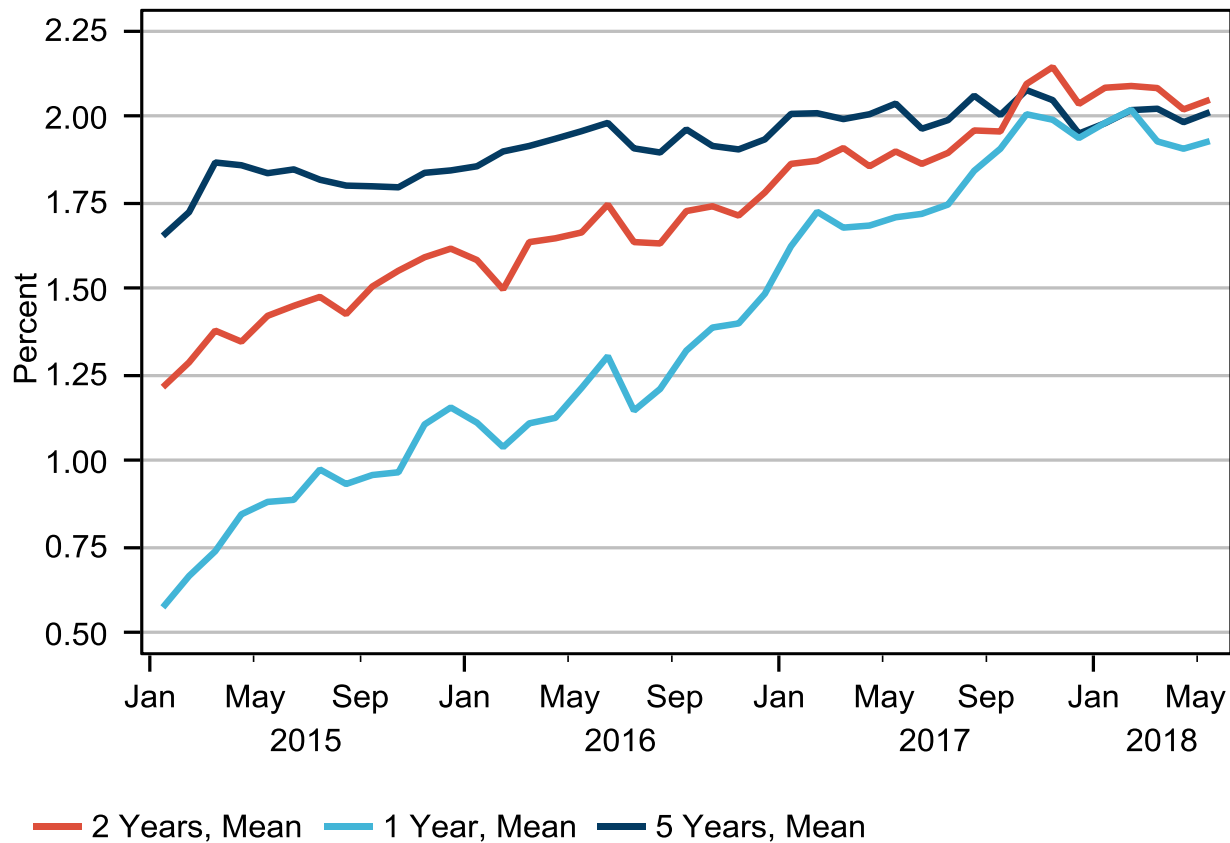
# UK: Inflation
